Purpose or Mission:

The Trust's objectives are to promote the sustainable management of the Porirua Harbour and its Catchment.

Structure:

The Trust was established jointly by Te Runanga O Toa Rangatira, Porirua City Council, Greater Wellington Regional Council, Wellington City Council and other individual community representatives who had a long term interest in the health of the harbour and catchment. The organisations named continue to be involved in the Trust through their representatives participating in the Board. Other Trustees and Advisory Trustees have also been appointed to the Board. The Board meets 11 times per year, broadly on a monthly cycle. It may meet at other times for particular purposes.

Main Sources of the Entity's Cash and Resources:

The principal income sources are donations from private sector organisations and grants from the Councils and Department of Conservation, which support community based activities.

Entity's Reliance on Volunteers and Donated Goods or Services:

The Trust undertakes projects that rely on voluntary effort - which is provided by Trustees and others. Governance and management is done by Trustees on a voluntary basis except to the extent where secretarial services and management of the Education Project are contracted out. No Trustees are paid for their services by the Trust. Some Trustees are Councilors of Territorial Authorities and may therefore be remunerated by those, though not directly as a consequence of their participation on the Trust Board.

Description of the Entity's Outcomes:

The objectives of the Trust are to promote the sustainable management of the Te Awarua-o-Porirua and its catchment by:

- a) Advocating for the sustainable management of the harbour and its catchment;
- b) Fostering the understanding of ecological and environment issues associated with the harbour and its catchment through education and community awareness;
- c) Coordinating input from community groups on issues relating to the harbour and its catchment;
- d) Supporting, promoting and contributing to programmes and projects aimed at improvements to the Te Awarua-o-Porirua Harbour and its catchment, where appropriate;
- e) Engaging in any other activities and processes that are complementary to any of the forgoing objectives.

Description and Quantification of Outputs:

1) Education Project: The number of schools involved is 49 (last

year 49). There is a deeper involvement of a number of these schools in the current year. The second edition of our schools journal was completed and 800 printed (last year nil).

2) Western Porirua Project: The project commenced this year involving

11 schools and early education centres. The project is partially funded by two CCEM

grants from DOC totalling \$65,000.

Note 4

There have been no changes to the approach to presenting the results this year. Last year the Performance Report payments relating to the Education Project and DVD Production were restated as Payments relating to goods or services (previously shown as Other Operating Payments).

Note 5

There were no transactions with related parties (last year Nil).

Note 6

There were no events after Balance Date requiring notification.

Note 7

The Trust is an ongoing entity but Trustees have the view that it should be wound up and replaced. The actual effective date is yet to be finalized and the wind up is subject to resolutions being passed at the appropriate meeting.

A new Trust Deed has been executed. It will facilitate the withdrawal of local authorities and Te Runanga O Toa Rangatira from direct involvement in the Trust at a governance level. Trustees will be drawn only from the community or more widely where they have particular skills. The strategic objectives of the new Trust are, in substance, the same as those of the existing Trust. It is intended that any assets of the existing Trust at its wind-up date will be transferred to the new Trust. Activities of the existing Trust will continue under the new one including delivery of activities for which the existing Trust has been funded.

Amounts within the Statements have been rounded to the nearer dollar.

Note 8

The Trust has sufficient Resources to operate until restructured into a new organisation or for the foreseeable future.

The Trust does not anticipate that the Covid-19 financial impacts, if any, will cause the Trust to alter its view that it is a Going Concern.
